Dear Parent / Carer

I are writing to inform you that on 23<sup>rd</sup> July 2024, the Conwy County Borough Council Education & Skills Cabinet agreed changes to Post 16 transport in the Conwy Home to School Transport policy effective from September 2025. These changes may affect your child if you wish to apply for free home to school transport to attend sixth form school or college from September 2025.

From 1<sup>st</sup> September 2025, free home to school transport for post 16 learners will provided to the nearest educational establishment (the nearest or catchment secondary school / Welsh medium school or to the nearest F.E. college) when it is three miles or over from the home address. Learners may be expected to make their own travel arrangements to a transport pick-up point. No learner aged 16 and over will be expected to make his/her own way more than 3 miles to a pick-up point. Transport will not be provided for residential courses.

All applications for post 16 transport must be made to Conwy County Borough Council via our webpage [Free School / College Transport - Conwy County Borough Council](#) by the closing date of 1st May 2025.
